hereinafter referred to as "Consumer" (or legal guardian of the consumer), as the first party and State-funded health institution in Kamchatskiy Krai, Petropavlovsk-Kamchatskiy "City Clinic for children #1"

Registered address: Kamchatskiy Krai, 5 Voitsesheka st., Certificate of Entry in the Unified State Register of Legal Entities, issued by the Inspection Office of the Federal Tax Service series 41 # 000543766, dated January 9, 2013; PSRN # 1024101035122, represented by medical director Svetlana Vladimirovna Kremer, who is acting based on the order # 481-к dated 26.12.2016 and medical licenses # ЛЮ-41-01-000918 dated 12.08.2019, issued by Ministry of Public Health, 683003, Petropavlovsk-Kamchatskiy, 118 Leningradskaya st., tel. 8 (4152) 42-47-02, in accordance with the annex #1 to this agreement, hereinafter referred to as "Service provider", as the second party, have signed this agreement as follows:

**1. Object of the agreement:**

**1.1.** Service provider assumes the obligation to provide medical services (list of the services) after Customer seeks aid:

(hereinafter – "Medical services"), and Customer (or the legal guardian of the Customer) assumes the obligation to pay compensation to the Services provider. The manner of payment, the amount due and the deadline are specified by this Agreement.

1.2 Services provider provides services at its location:

Petropavlovsk-Kamchatskiy, 5 Voitsesheka st.

**2. Manner of payment**

**2.1.** The cost of the rendered medical services is set in accordance with the approved price list. The amount due is \_\_\_\_\_

**2.2.** The Consumer (or legal guardian of the consumer) makes payment for the services provided to the pay-office of the Services provider. The Services provider issues sales receipt accordingly.

**3. Conditions and time limit for rendering medical services**

**3.1.** Services are rendered by doctor \_\_\_\_\_

**3.2.** The services are to be provided in the time period between the signing of the Agreement by both parties until the fulfillment of the contractual obligations, but no more than \_\_\_\_\_ days, beginning with the day the Agreement was signed.

**3.3.** The time frame during which the services are to be provided can be changed upon a mutual agreement by the parties. In this case an additional agreement should be drawn up where factors contributing to the change are to be stipulated.

**4. Rights and obligations of the parties**

**4.1. The Services provider is obliged:**

4.1.1. To provide the Consumer (or legal guardian of the Consumer) with valid free information on rendering of the medical services in accordance with current legislation.

4.1.2. To render services, specified by this Agreement, to the Consumer (or legal guardian of the Consumer) as stipulated in this Agreement.

4.1.3. To be duly liable for the quality, amount and provision of the medical services.

4.1.4. To issue the Consumer (or legal guardian of the Consumer) sales receipt which will confirm the payment made by the Consumer for the medical services rendered.

4.1.5. To preserve physician-patient privilege and maintain the privacy of the Consumer (or legal guardian of the Consumer).

3.1.6. To provide the Consumer (or legal guardian of the Consumer) with the printed material on the medical services rendered.

**4.2 The Consumer (or legal guardian of the Consumer) is obliged:**

4.2.1. To provide with the Services provider with the information on the state of his or her health (or the health of the underage patient).

4.2.2. To provide the necessary medical documents and materials upon request of the Services provider.

4.2.3. To sign Patient Informed Consent for medical treatment (as specified by Annex 2 to this Agreement).

4.2.4. To pay for the services rendered by the Services provider within the time frame and under conditions stipulated in this Agreement.

4.2.5. To make the payment and provide the issued receipt to Services provider for information purposes.
